Community Development Project for South Asian Low-income Individuals: Dream Lighter's community development project serves over 2,000 South Asian Taxi drivers and low-income immigrant families in New York City, providing programs that address immediate needs while fostering long-term economic stability and generational wealth. The program delivers more than 25 annual workshops on financial literacy, credit management, budgeting, small business operations, public safety and navigating the American economic system, equipping participants with practical skills to improve personal finances and plan for the future. In addition, Dream Lighter convenes five international summits at venues including the Sheraton and Marriot, along with six annual outdoor assemblies in New York State Park, engaging thousands of participants to strength social cohesion, civic engagement, and community networks. Through strategic partnership with local mechanics and body shops, participants access discounted automotive maintenance and repairs, lowering operational costs and enhancing (contd scd O)

Community-Based Microloan Program: for Low-Income Taxi Drivers In 2023, Dream Lighter launched a community-based microfinance program in New York City serving low-income taxi drivers. Approximately 400 participants collectively raised \$400,000 to form a revolving loan fund, with an average contribution of \$1,000 each. Through a transparent lottery Approximately 400 participants collectively raised \$400,000 to form a revolving loan fund, with an average contribution of \$1,000 each. Through a transparent lottery new loans each month. Borrowers repay \$430 monthly at a 3% interest rate. These funds are recycled to ensure the fund's continuous lending activity and sustainability. This approach ensures liquidity, transparency, and prudent stewardship of charitable assets, consistent with nonprofit community-development practices.
